
Dear Madam,

We act for our clients who are practising Sonologists in the State of Karnataka and members of the Medical Ultrasound Society of Karnataka in Bangalore, on whose instructions we write to you as follows:

As you may be aware, W.P. Nos.32922-955/2016 has been filed by some of our clients before the Hon'ble High Court of Karnataka *inter-alia* challenging the amendment to the PC&PNDT Rules, 1996 and consequently your action of holding the competency based exam for practising Sonologists under the said Rules. By Interim Order dated 13<sup>th</sup> June 2016, the Hon'ble High Court has restrained you and the Union of India from acting in any manner under the said Rules against the Petitioners therein pending disposal of the Writ Petition. We enclose a copy of the above order for your reference.

You may please note that several other of our clients, also practising Sonologists in Karnataka, have filed W.P. Nos.33662-689/2016 for identical relief, which was taken up for hearing by the Hon'ble High Court today and similar Interim Order has been granted. This is for your information.

Respondents are restrained from acting in any manner against the petitioners under the impugned Rules subject to the result of the writ petitions.

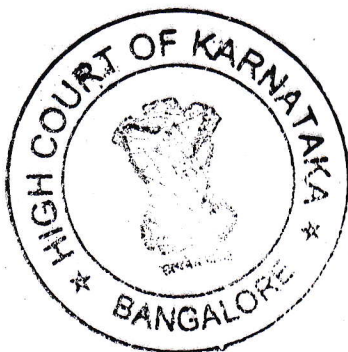
